## FIRE PROTECTION HYDRANT/CISTERN APPLICATION FORM

Permit fee: \$25.00 payable to the "Town of Brentwood, NH".

If you are installing either a dry fire hydrant or a cistern, the Brentwood Fire Department requires certain information **prior** to installation.

Plans and installation shall conform to NFPA 1, NFPA 1141 and 1142 editions as adopted by the State of NH Fire Code, SAF-C-6000 and local ordinances and Brentwood zoning, site plan and Planning Board rules and regulations.

### INFORMATION NEEDED:

This application shall be filled out completely and returned to the Fire Prevention Division.

Submit two (2) sets of COMPLETE plans. "Complete" means that plans and application SHALL be accompanied with a letter from the designer/Engineer that plans meet all requirements as required by state code and local ordinances. The plans submitted shall include specification sheets for all tanks, piping and all other devices associated with the installation.

**Approved plans must be on file with the Brentwood Fire Department and a permit issued BEFORE installation work begins.**

Plans that have been reviewed by the Prevention Division will have a copy of the approved plans returned to the installer. The Division shall be notified and review any deviations from the approved plan before final testing.

The Division may require a copy of the underground-piping certificate prior to inspection, depending on the system being installed. Inspections may include a 24 hour leak test, vacuum test and witnessed flow test using BFD apparatus and a timeline for installation and testing shall be provided to the Department. Tanks shall be full prior to testing, and water used during testing will be replaced by BFD. Winter installations may have a delay in testing until safe to do so, upon approval of BFD.

**All inspection requests require 3 day minimum notice by installer. A Fire Official shall witness any required tests as required in NFPA documents.**

The contractor must sign this form in the spaces shown below indicating that all plans and required forms will be submitted and that the contractor is aware that the occupancy/building permit may be held up by the Division until all conditions on installations, testing and life safety have been met.
